

<b>FACTS</b>	<b>WHAT DOES ASCEND LOANS, LLC, DO WITH YOUR PERSONAL INFORMATION?</b>	
<b>Why?</b>	Financial companies choose how they share your personal information. Federal and Tribal law gives consumers the right to limit some but not all sharing. Federal and Tribal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	<p>The types of personal information we collect and share include:</p> <ul style="list-style-type: none"> <li>· Information that you provided to us in your loan application, including:             <ul style="list-style-type: none"> <li>· Name, address, email address, and other contact information</li> <li>· Social Security number</li> <li>· Banking information</li> <li>· Information about your employment</li> </ul> </li> <li>· Rather than applying directly with us, you may have submitted your information to a third party website – a lead generator – which is designed to connect individuals seeking credit with online lenders who may be able to offer credit. The lead generator then presented your information to us to evaluate. The exact information provided may differ depending on which lead generator you submitted your information to, but it will include, at a minimum, the information identified in the previous bullet.</li> <li>· Information we obtain about you from other parties such as:             <ul style="list-style-type: none"> <li>· Information obtained from one or more credit reporting agencies that we use in the course of underwriting your application.</li> </ul> </li> <li>· Information about your transactions, such as:             <ul style="list-style-type: none"> <li>· If you obtain a loan with us, we keep track of your payments and loan performance. This helps us offer you products and services we think you'll like, and we also use it for internal reporting, improving our services, and other business purposes.</li> <li>· This includes any transactions you've engaged in with our affiliated entities.</li> </ul> </li> <li>· IP Addresses</li> <li>· Cookie identifiers</li> <li>· Tracking technologies (pixels and end user activity)</li> </ul>	
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reason Ascend Loans, LLC, chooses to share; and whether you can limit this sharing.

<p><b>Who is providing this notice?</b></p>	<p>Ascend Loans, LLC is providing this privacy notice and it applies to all loans made by the company and all products and services offered in connection with such loans.</p>
<p><b>What we do</b></p>	
<p><b>How does Ascend Loans, LLC, protect my personal information?</b></p>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal and Tribal law. These measures include computer safeguards such as 256-bit AES encryption of data in transit and at rest, compliance with standards such as PCI-DSS, as well as physical security measures in our call center.</p>
<p><b>How does Ascend Loans, LLC, collect my personal information?</b></p>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>· Apply for a loan</li> <li>· Give us your income information</li> <li>· Provide employment information</li> <li>· Direct us where to deposit funds</li> <li>· Give us your contact information</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<p><b>Why can't I limit all sharing?</b></p>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>· Sharing for affiliates' everyday business purposes information about your creditworthiness</li> <li>· Affiliates from using your information to market to you</li> <li>· Sharing for non-affiliates to market to you</li> </ul>
<p><b>What happens when I limit sharing for an account I hold jointly with someone else?</b></p>	<p>Ascend does not provide joint accounts.</p>
<p><b>Age Restriction</b></p>	<p>We do not knowingly collect personal information from anyone under the age of 13. Ascend's services are limited to users 18 years of age or older. We recommend parents monitor their children's internet usage.</p>

Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none"> <li>· Our affiliates include companies within the Ascend Loans, LLC, corporate family</li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and non-financial companies. Non-affiliates to whom we transfer your information are only allowed to use that information for specified purposes.</p> <ul style="list-style-type: none"> <li>· Non-affiliates with whom we share information can include direct mail providers, other companies that help us market our services, debt collectors, data providers, and credit reporting agencies.</li> </ul>
<b>Joint Marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>· Joint marketing partners can include financial institutions, marketing firms, and other lending companies.</li> <li>· Ascend Loans, LLC, does not engage in joint marketing.</li> </ul>
<b>Digital Advertising</b>	<p>Ascend Loans, LLC, utilizes advertising platforms who are NAI Members to distribute tailored online ads. <b>Tracking Information</b>	<p>When you visit the Ascend website, a cookie is placed on your computer if you accept cookies. The cookie we place on your computer may include personally identifiable information that you provided to Ascend. Ascend advertises its products and services on websites that you may visit and uses service providers to place such advertisements. Those service providers (such as Google, Microsoft, Yahoo, Facebook, Instagram, and other platforms) may use cookies placed on your computer to show you advertisements for Ascend services on other websites. You can opt-out from service providers' use of cookies in this manner by visiting each service provider's advertising opt-out page or by utilizing "do not track" functionality in your web browser. Note that if you choose to not have your browser accept cookies from the Ascend website, not all features may operate as intended – for example, if your browser shuts down in the middle of the application process, you may have to restart the process.</p>
